Dear Iapparova Family:

It is our pleasure to provide you with an opinion and treatment options for Elizaveta. Based on the medical records you provided, which have been reviewed by Dr. Sitaram Emani and Dr. David Schidlow, Elizaveta may be a surgical candidate as outlined in Dr. Sitaram Emani's April 29, 2024 letter.

The Cardiovascular Program is pleased to extend an inclusive global discounted rate. This rate is **USD \$247,161.98** and includes the following services at Boston Children's Hospital: cardiac evaluation prior to catheterization and cardiac surgery, MRI, 3D model, catheterization, cardiac surgery, hospital admission for catheterization and cardiac surgery, and related medical services while inpatient. This rate also includes 1 post-discharge cardiac visit and cardiac testing before your return home.

Upon discharge from the hospital, if Elizaveta were to need outpatient services such as medication, oxygen, physical therapy, etc., those costs would not be covered under this rate.

Please understand the above is a global discounted rate and we will cover all charges associated with care from the Cardiovascular Program. In the unlikely event that the diagnosis and/or procedure are different from originally planned, this discounted rate will no longer apply.

This rate does not include any treatment or care by other specialties (such as Ortho, Neurology, Dental, etc.). **Please note this rate is extended to self-pay international families and not to insurers, government agencies, or non-profit organizations. Statements required for insurance refunds will not be provided.**

We recommend staying in the Boston area for approximately 4-5 weeks for Elizaveta's recuperation and post-operative appointment.

As you are arriving to Boston Children's Hospital solely for clinical services, the clinical team expects your care to be repatriated to your home health care system/provider for post treatment care after your post-procedure appointment which will be noted in the medical record.

**Important financial information below. Please read carefully.**

The U.S. Department of the Treasury's Office of Foreign Assets Control (OFAC) administers and enforces U.S. economic and trade sanctions programs against targeted foreign governments, individuals, groups, and entities in accordance with national security and foreign policy goals and objectives. Any funds transfer that involves a financial institution operating in Russia will require an OFAC license in compliance with current sanctions enforced by the US Treasury.

Families wishing to proceed with the services outlined above must adhere to the guidelines set out by U.S. Treasury. Our bank is required to comply with sanctions, laws, and regulations administered and enforced by OFAC and other U.S. agencies. In addition to the U.S. sanctions, the bank is required to comply with the economic sanctions, laws, and regulations of the countries where they operate.

A total deposit of **\$247,161.98** must be received in full 50 days prior to the first appointments and surgical date. Please take into account any additional processing fees that might be associated with a wire transfer (for example, via an intermediary bank). We ask that you coordinate with the financial institution to ensure **\$247,161.98** is fully received prior to the start of services.

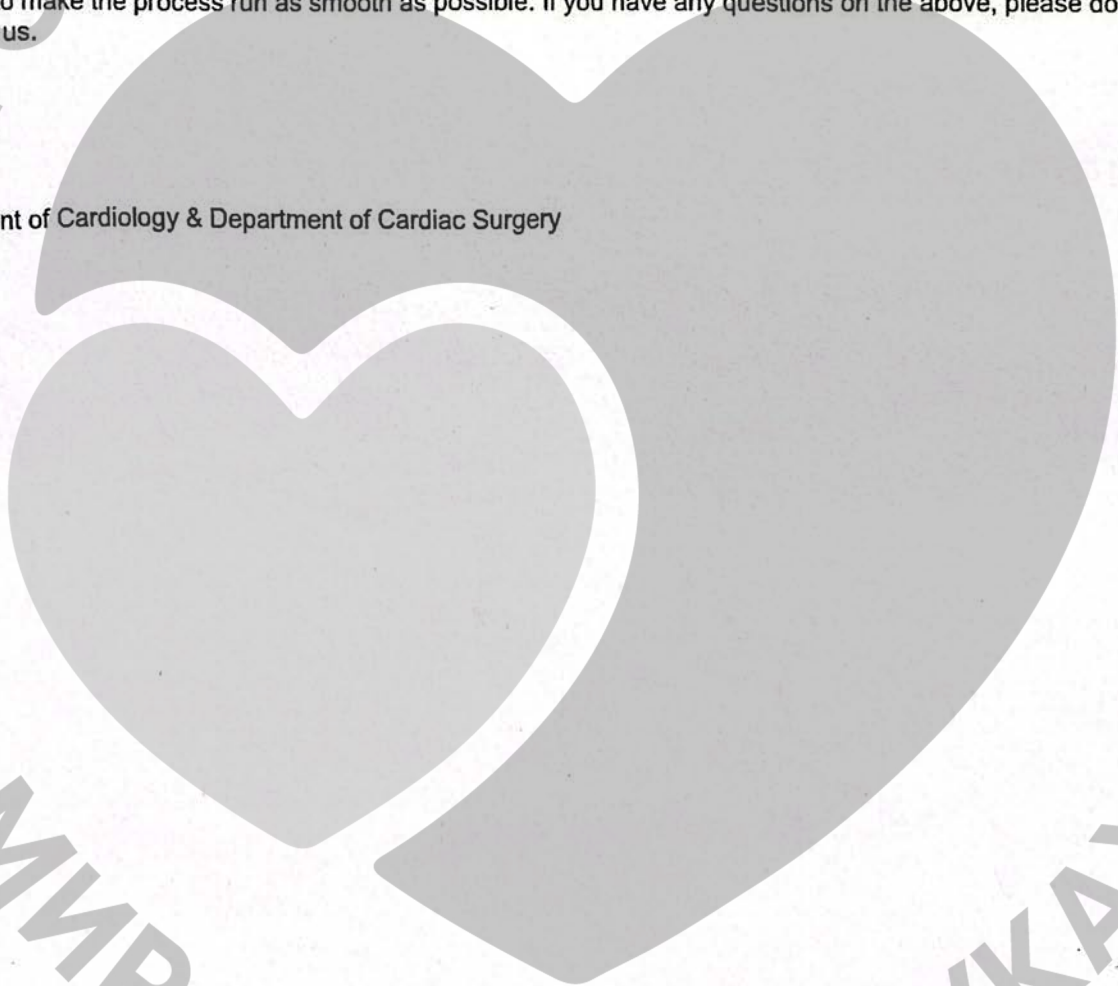
